



The undersigned (hereinafter “Member”) hereby makes application to the Doniphan Electric Cooperative ASSN., Inc., (Hereinafter “Cooperative”) for electric services upon the following terms and conditions below and on the reverse of this document.

**1. Membership** – Membership shall be either individual or joint. The Member(s) shall pay the Cooperative a one-time nonrefundable sum of \$20.00, which, upon acceptance of this application by the Board of Trustees of the Cooperative, shall constitute the Membership Fee. Subsequent meters for electric service needed by the Member will not require a membership fee.

**2. Payment** – The Member will, when electric service becomes available, will pay monthly at the rates and terms which are filed and approved by the Cooperative’s Board of Trustees. The Member will pay the Cooperative for all other goods or services provided at the rates ( attached), and upon the terms and conditions set forth in the Cooperative’s rules and regulations ( attached) and price schedules as they now exist and as they may be modified from time to time in the future.

**3. Delivery of Service** – Service to be furnished under this agreement is to be delivered and received at a mutually agreed point. The Cooperatives meter shall constitute the point of delivery to the Member and the Member will own and maintain all wires, equipment and other facilities beyond the point of delivery.

**4.** The Member hereby gives written consent to the Cooperative to transfer to the Members current service account, regardless of class, any unpaid balance owed for service received or costs incurred at this or any separate metering point, residence or location, regardless of the class of service received or when such service was received whether prior, concurrent, or successive.

**5. Wiring** – The Member will cause his/her premises to be wired in conformance with the National Electrical Safety Code and all applicable city and County specifications.

**6. Additional Provisions** – The member or joint member will, as a member of the Cooperative, comply with and be bound by, as though fully set herein, the provisions of the Bylaws of the Cooperative, and any Rules and Regulations and Rate Schedules may, from time to time, be adopted by the Cooperative’s Board of Trustees.

**7. Continuity of Service** – The Cooperative will use reasonable diligence to supply continuous electric service but does not guarantee the supply of electric service against irregularities or interruptions. In no event shall the Cooperative be liable for damages from irregularities or interruptions of service caused by, but not limited to, an act of God, government authority, action of the elements, public enemy, accidents, labor disturbances, strikes or their equivalent, sabotage, vandalism, required maintenance work, legal process, inability to secure rights-of-way or other permits needed, or for other cause(s) beyond the control of the Cooperative.

**8. Personal Liability** – The Member, by paying the membership fee and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law the private property of the Member cannot be attached for any such debts or liabilities.

**9. Security Deposit** – The Cooperative may require the Member to provide credit information prior to rendering electric service. The Cooperative may also require at any time, upon proper notice, a security deposit in accordance with the Cooperatives Rules and Regulations. Such deposit will bear interest and be refunded in accordance to those Rules and Regulations.

**10. Capital Credits** – Capital credits will be refunded in accordance with Cooperative rules, regulations and policies now in effect and as they may be modified in the future, when approved by the Board of Trustees.

**11. Access** – The Cooperative will have the right of access to the Member’s premises for the purpose of installing, reading, inspecting, or repairing any meters, devices, or other equipment or for any purpose incidental to the electric service supplied by the Cooperative.

**12. Term** – The acceptance of this application by the Cooperative shall constitute a binding agreement between the Member and the Cooperative and the contract for electric service shall continue in force from the date service is made available hereunder to the Member, and thereafter until canceled by the Member (by a written or digital request) or by disconnection of the Member’s service by the Cooperative.

**13. Waiver** – No representative, agent, or employee of the Cooperative shall have the power to amend, modify, alter, or waive any of the provisions or terms of this contract or any of the general terms and conditions relating not herein contained. Any promises, agreements, or representations made by any representative, agent, or employee of the Cooperative not herein set forth shall be void and of no effect.

**14. Joint Liability** – If the Member is more than one person then each Member is jointly and individually liable for all debt incurred.

**15. Compliance** – Failure on the part of the Member to accept service from the cooperative, to comply with the Bylaws, Rules and Regulations, or to carry out the terms and conditions of this contract, shall not relieve the Member from the payments and conditions set forth in this contract.

**16. Member** – Member shall mean any person signing this agreement for electric service whether he/she is a member or becomes a member of the cooperative.
